- Eligible candidates must apply online only after reading the instructions given here below thoroughly and carefully after checking the eligibility criteria given above before submitting the online application.

3. **Important dates for Online Application:**

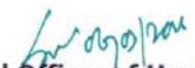
- a. **Starting date for Online Registration : 6<sup>th</sup> March, 2026**
- b. **Last date of Online Registration : 12<sup>th</sup> March, 2026**
- c. **Last date of Submission of application fees online : 12<sup>th</sup> March, 2026**
- d. **Last date of Full Submission of Online application form : 13<sup>th</sup> March, 2026**

**N.B. : Online Registration is mandatory for all online applications.**

4. Cut off date for calculation of age will be **01-01-2026**

5. **All essential criteria must have been fulfilled on or before the starting date of online application as given above.**
6. Only Online Application uploaded in the recruitment portal of the State Health Website, [www.wbhealth.gov.in](http://www.wbhealth.gov.in) will be accepted, no need to send the hard copy /print copy of the online application to the office of the undersigned.
7. Application fees (Non-refundable) of **Rs.100.00** (Rupees One hundred) only for UR candidates and **Rs.50.00** (Rupees Fifty) only for the Reserved category must be submitted through Online mode only. **The Online deposition of application fees can be done through Net banking or Credit card/Debit card /UPI.** If the payment is successful then the candidate will be immediately reverted back to the link for Final submission of the Application form by using the **Application ID** already received at the time of Registration. **Candidates are to note that the Application ID generated at the time of Registration is to be noted and kept safely for further use during the online application.**
8. Online Registration number is to be retained by all applicants for further reference and use. The District Level Selection Committee/District Health & Family Welfare Samiti, Uttar Dinajpur is not liable to give any information about the online registration numbers to the applicants at any point of time.
9. Online Application not properly filled up or incomplete Applications are liable to be rejected. Further, if the details furnished in the online application submitted by the applicant differ with the details in the original testimonials, the application is liable to be rejected/cancelled.
10. **If the online application does not have the signature as well as the photograph of the candidate uploaded, the application is liable to be cancelled.**
11. After successful submission of the online application, the candidate must download the duly filled up application form and keep a printout ready for future reference.
12. **The essential qualifications mentioned in the criteria for selection are the minimum criteria and mere possession of the same does not entitle the candidate to claim selection.**
13. All the posts are purely on contractual basis and engagement is valid up to the end of the same financial year in which the candidate joins the post. The tenure of engagement may be further extended on the basis of performance and subject to continuation of the said posts by the State Health & Family Welfare Samiti, West Bengal.
14. **The following self-attested photocopies of the essential testimonials are to be submitted during document verification and should be considered only after the production of relevant original documents.**
  - a. One copy Print out of "**online application form**" duly signed by the candidate in the specified place denoted as "Signature of the Applicant" after the declaration.

- b. **Mark Sheets & Certificates:** Copies of Mark Sheets (**FOR ALL YEARS**) & **CERTIFICATES** of Madhyamik or equivalent examination, Higher Secondary or equivalent examination, Graduation degree, Master Degree etc. (as applicable against post/s applied for). Copies of Mark sheets of all semesters/years in respect of all degrees are a must.
- c. **Proof of Date of Birth :** age proof like Birth Certificate / Admit Card or Certificate of Madhyamik Pariksha or equivalent / PAN Card / Passport issued by the competent authority.
- d. **Residential Proof :** Passport / EPIC (Voter ID Card) / AADHAR Card / Driving License issued by the competent authority.
- e. **Caste certificate :** SC/ ST/ OBC-A/ OBC-B Certificates issued by the competent authorities of West Bengal only. In case of OBC candidate's category 'A' or 'B' must be mentioned specifically in the caste certificate otherwise the candidate will be treated in "Unreserved" category.
- f. **EWS certificate :** In case of Economically Weaker Section (EWS), applicants must produce the EWS certificate issued by the competent authority of West Bengal only for the current financial year.
- g. **Photo identity proof :** Passport or EPIC (Voter ID Card) or AADHAAR Card or PAN Card.
15. **If, at any stage of the recruitment process, if any false information furnished or suppression of any material in the application coming to notice, at any time during the recruitment process or thereafter, (i.e. during written examination, document verification, interview, joining and even during service) and if a candidate is found to have engaged in any misconduct, his/her candidature is liable to be rejected immediately or services would be liable to be terminated without any further notice.**
16. District Level Selection Committee (DLSC) reserves the rights regarding the total recruitment process and may cancel/ modify the recruitment process at any stage of selection process which deems fit.
